The city of Augusta may want to piggyback on the same bid.

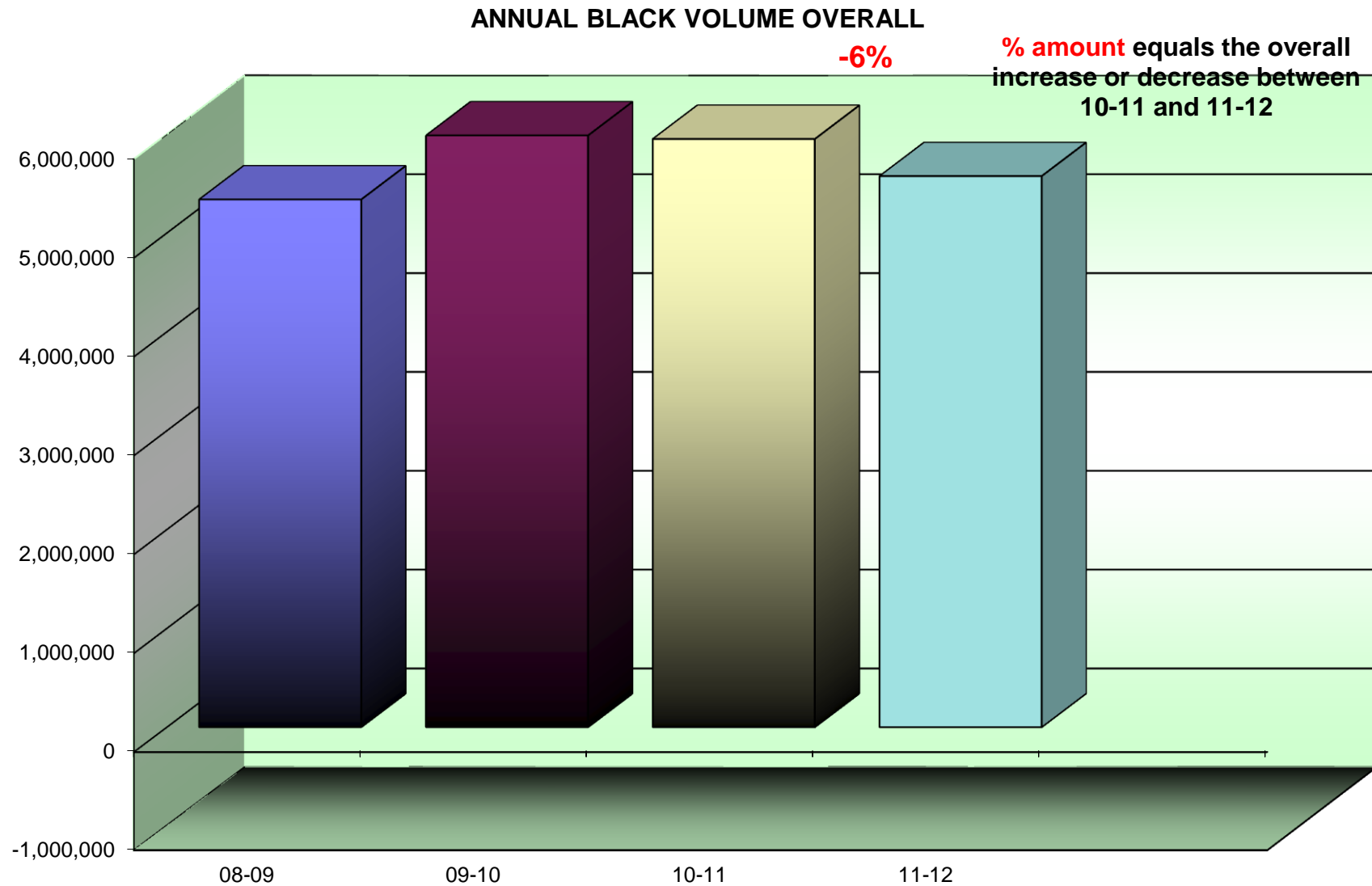

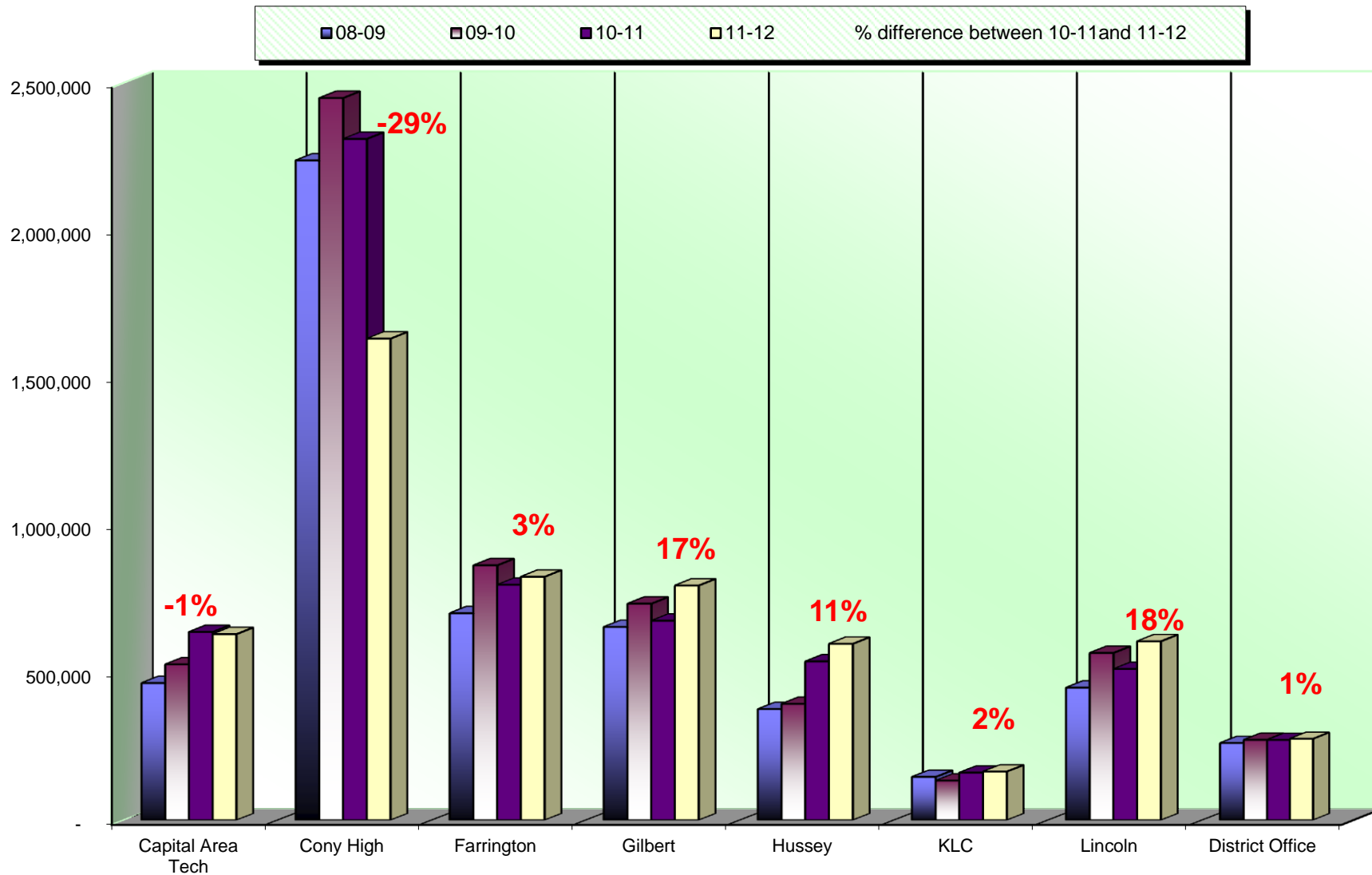

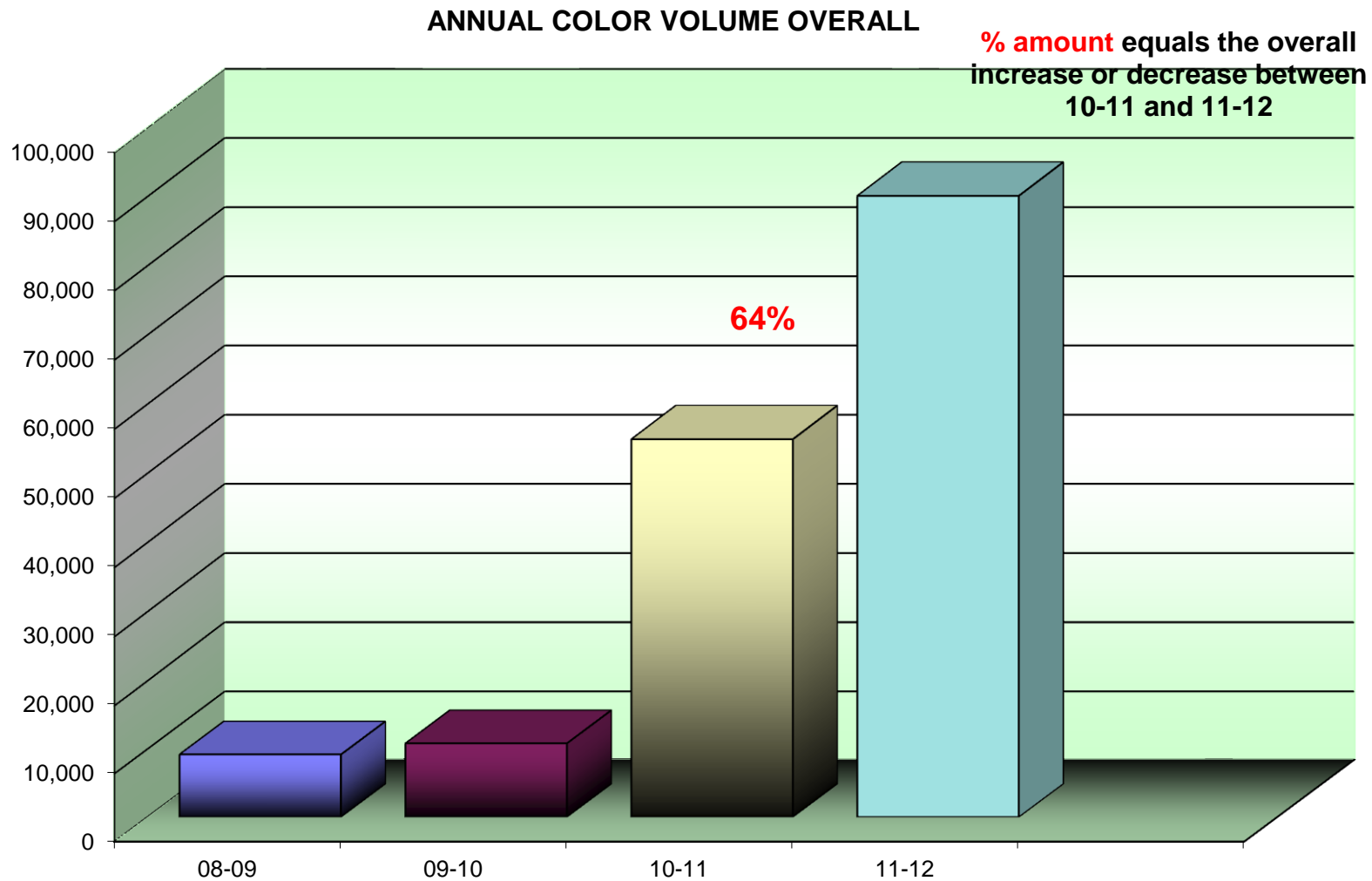

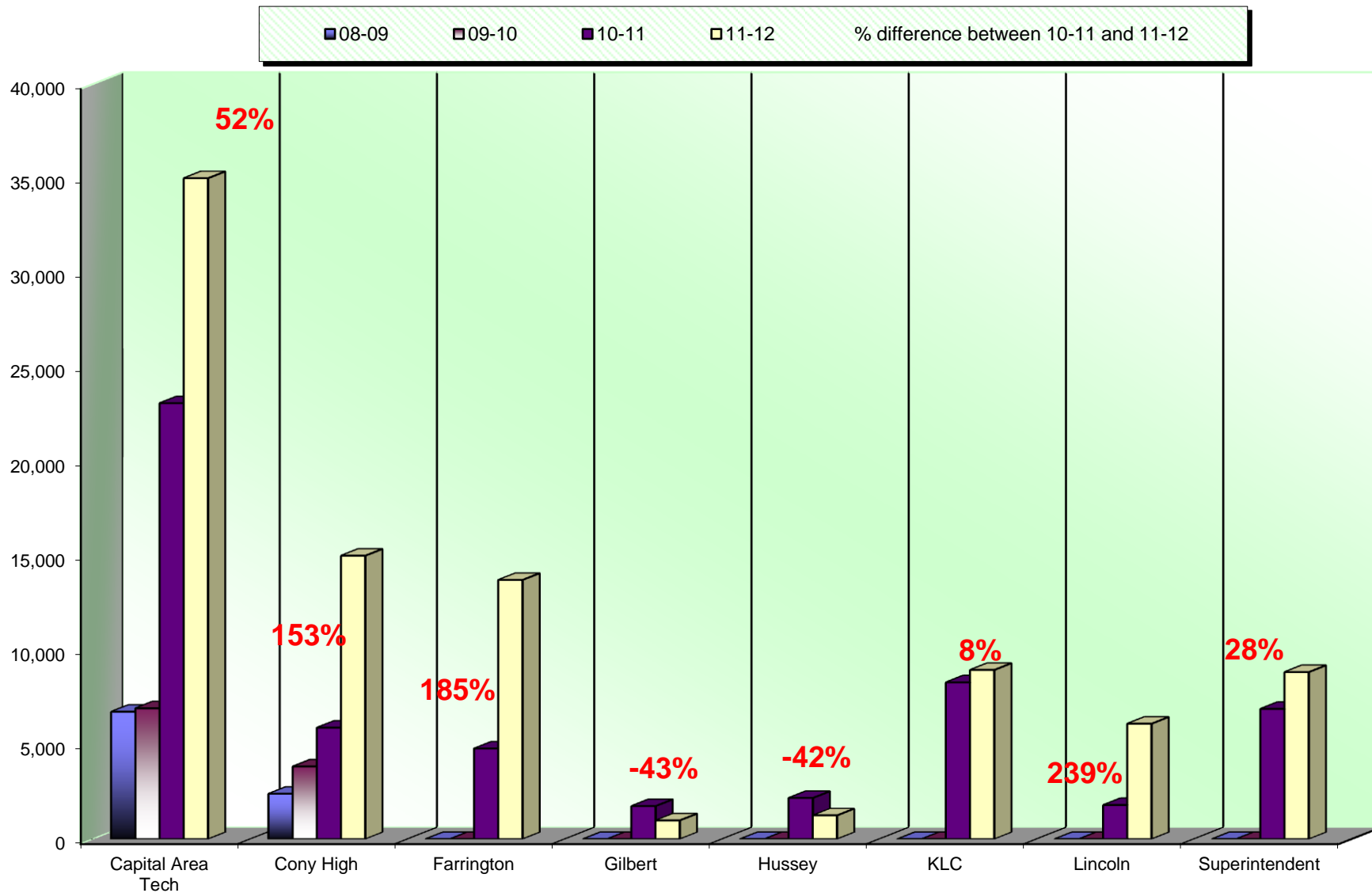

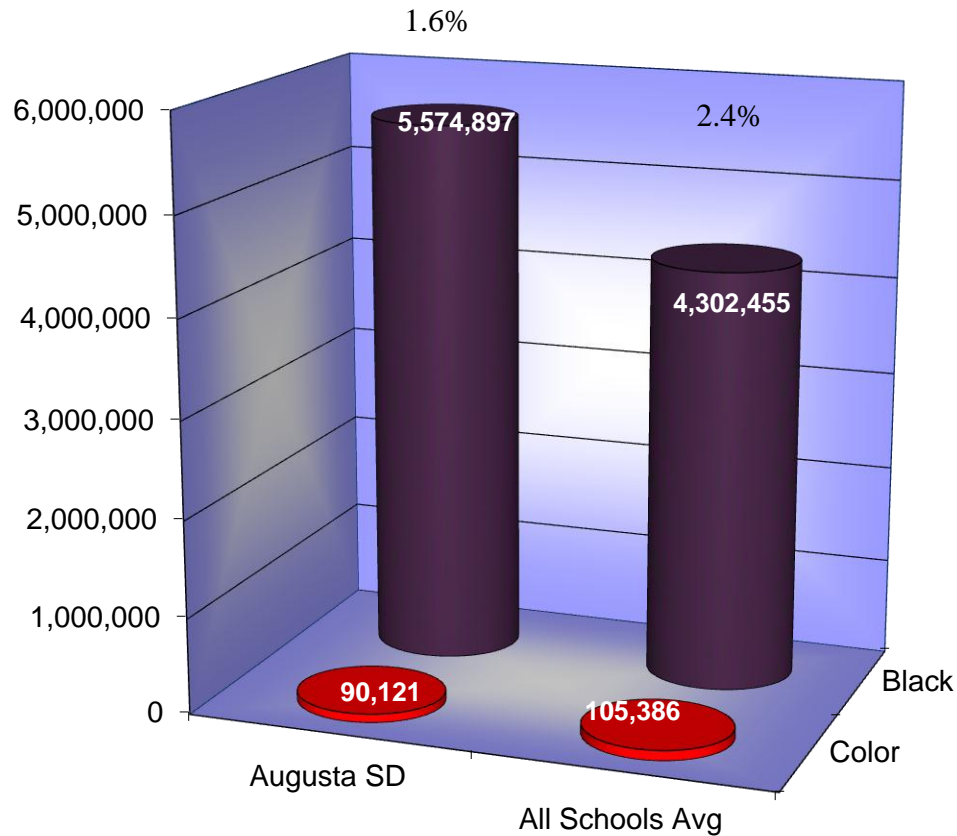
ANNUAL COLOR VOLUME BY BUILDING

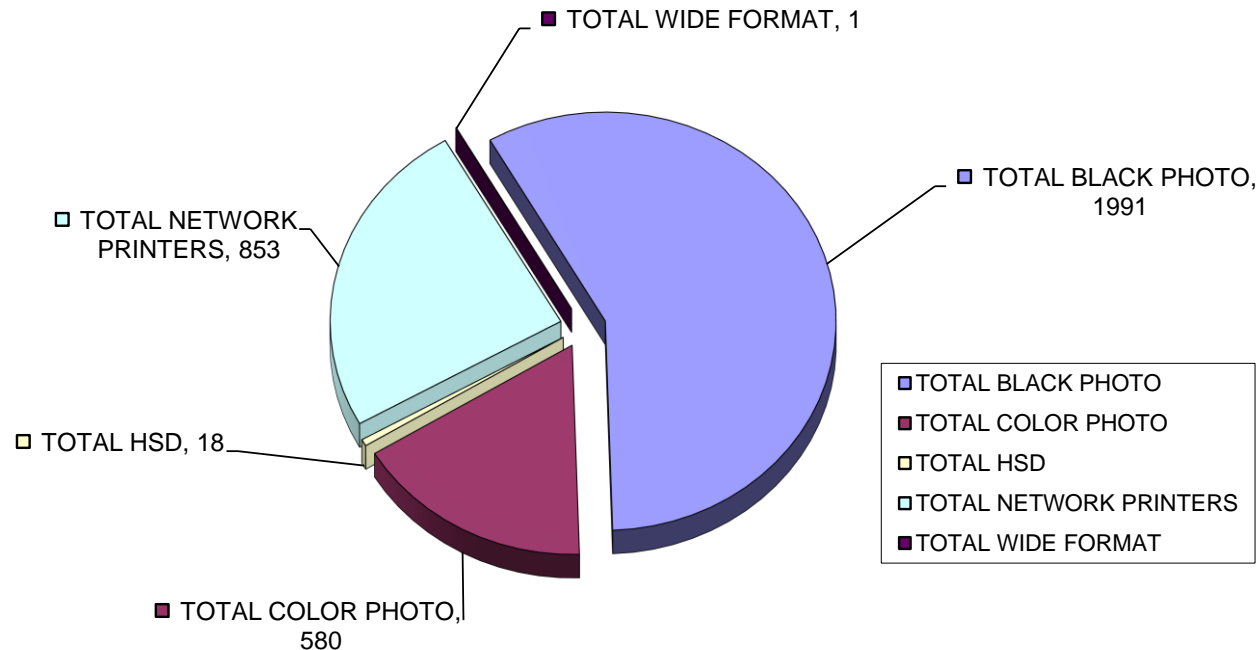
