We did see a slight improvement between the report we ran in April and the current report as far as copies between calls and average uptime percent. However, one copier at the Police Department had an additional 6 service calls (bringing the calls to 9 for that one copier) since April. Details of those calls are in the yellow box following the table. Four other machines each had one more service call., with two other problem locations increasing their overall totals for the year. Details for those with more than 5 service calls are described in the yellow box below the table. You would do well to consider updating some of your equipment as it is aging and parts will be harder to locate for repairs.

SPC's Bid Specs require vendor to arrive within 4 hours; however, each vendor calculates these figures differently

BH554E, A61D011006419, Fire Department: Unit had 5 service calls between July 30 and February 19. These calls were for paper jams (3) and error codes (2). Each call was for a different issue or code. The last service call was at the end of May for a paper jam in the duplex unit.

BHC454E, A5C0011023149, Police Department: This unit had 9 service calls within the fiscal year, which is quite high for a machine with such relatively low volume. The service history revealed a service call in July for an error code due to a paper jam in the 1st paper tray, with rollers being replaced; the next call was for a paper jam in April and an error code in the Fusing Unit later in the month. There were 7 service calls between June 10 and June 25 for Error codes in the Image Reading Unit and the Document Feeder - 4 for the former and 3 for the latter. Parts were ultimately replaced on the last two calls.

BHC454E, A5C0011023468, City Hall: This unit experienced 7 service calls between October 15 and March 4. At least 2 calls took place and were resolved on the same day. Three calls were for jamming, while the others were toner issues, failure to print, and error codes for various issues.

BHC454E, A5C0011023485, Public Works: There were 7 service calls for this copier. The first call was in July for a jam in the document feeder; there were two calls in November for different issues, two calls for noise in December/January, another call for a jam with the drum and Fusing Unit being replaced in April, and one call for an issue with the fax controller, which was replaced.
