

They cannot print as the machine due to continuous jamming. They have had multiple technicians from A-Copi here looking at it and they still can't print. The last technician left yesterday stating that he can't figure out why it's continuously jamming thinks there may be a broken spring. Would return with parts to do more troubleshooting. This is a brand new machine was installed 9/8/16.
10/17/2016	Matt Vincunas of A-Copi sent an e-mail to all parties stating that they resolved the problem as of Friday, October 14. It turned out to be a bad sensor within a certain section of the machine. They replaced the sensor and the unit no longer jams. Per Matt, "Since these machines have so many sensors within the machine, it is not uncommon for us to see one go bad occasionally and cause an issue like this." They will return copier on Tuesday 10/18.




Annual Black Volume by Building




Annual Black Volume Overall



Annual Color Volume by Building




Annual Color Volume Overall
