Overall Description of Equipment Fleet:

Presently, you have Six different Manufacturers & Dozens of different Models of Low end Network Printers that are costing you from \$0.12 for Ink Jet & \$0.035 per black print. Color prints are costing you as high as \$0.40 per print! The new arrangement will shift to two manufacturers...Konica Minolta with just one company servicing everything. This will greatly reduce cost and improve reliability.

Capital:

Presently, you have one municipal lease that is paid off on 8/2/2014. With the new arrangement, you will again have one 'municipal' master lease at **2.59%** interest. You will have a small interest only lease payment of **\$1,140.96** (this will be in conjunction of your scheduled current lease payment of **\$59,141.85**) on **8/1/2014**. Your first of five annual lease payments will be due on **August 1st 2015**. A legal opinion from SPC's bond counsel (John Larouche in Augusta ME) will be done on this lease transaction. This will assure that all documents are prepared correctly and signed by the appropriate school and bank officials, and that the lease purchase is a tax-exempt obligation with no premium payable by the school district for prepayment. At your own expense, you can have your own bond counsel also review the documents which would simply duplicate this service.

Service & Supplies:

Considering all of your consumable cost centers including service you are averaging **\$0.004426 for black and \$0.070026 for Color.** The new contract will come in at a CPC of **\$0.004013 for Black and \$0.059424 for Color.**

Vendor Packages:

SPC has brought to you **Nine** different vendor combinations, matching up the best technology available to meet your needs. We would like to highlight the most qualified bid combination, which is **KMBS with Konica Minolta.**

*Although the lease cost does down the service and supply cost savings also goes down. Note that with the last upgrade only **26 New units** were purchased while **46 New units** are part of the new lease!

The successful bidders will have a blanket servicing contract that includes all consumables excluding only staples and paper for all of the equipment that is under their factory authorized ability to service. They will provide one easy 'Cost per Copy' billing plan done once a year in June-July. Your service contract will be fixed through **June 30th 2015**. A contract extension has been negotiated for four more years, which will have an annual price ceiling of five percent or CPI, whichever is less. You however, only commit funds for one-year at a time to the servicing vendor. And even this scenario allows you to upgrade, lowering the service costs, if it is to your advantage to go out to bid at any time. SPC will set up both the service- supply contracts and the warranty cards with the successful bidding vendors.

Security package: Wiping out old data on trade out units has been included in the package.
